(S.R. 139), Garden Walk Blvd., S.R.-85, Forest Pkwy., Old Dixie Road, Old Dixie Hwy., Charles W Grant Pkwy., into Hartsfield-Jackson International Airport (International Terminal).

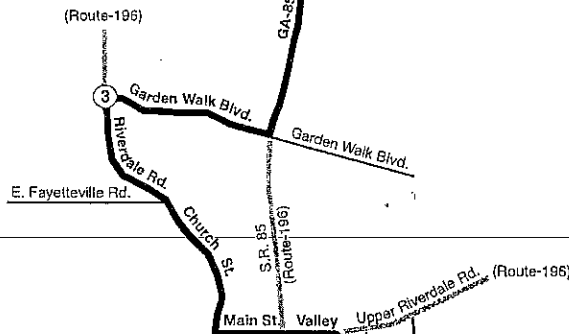
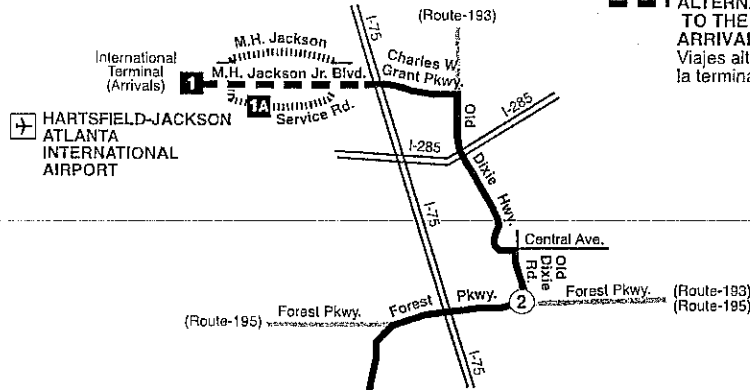

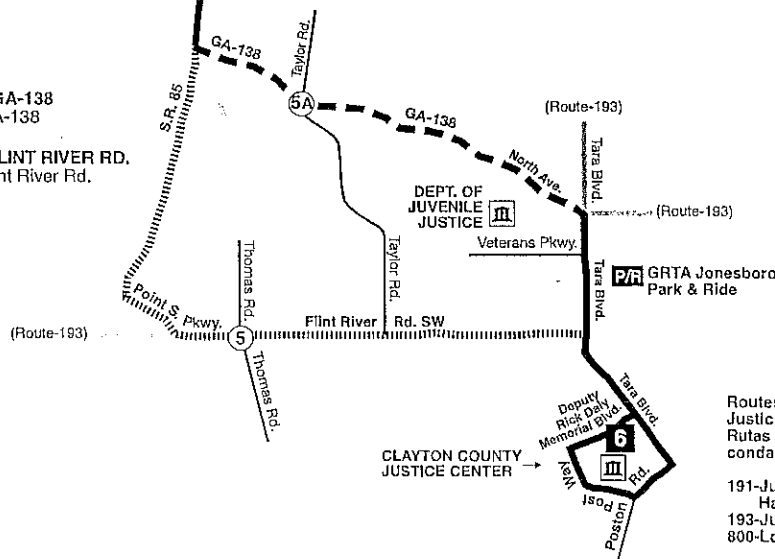
